- 4 The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website:www.cbse.nic.in.
- 5 It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
- 6 It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
- 7 It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time

9. It will continue to pay Annual Fee of Rs 3000/- per annum. The schools run by Govt/Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee to CBSE by D D /Cash in favour of Secretary, CBSE, payable at CBSE, H.Q., Preet Vihar, Delhi-110092. Annual fee has been received upto 31/03/2019.
10. The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates.
11. Special condition to be completed within 03 months.
  1. The school is required to appoint Special Educator as per rule 13(11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015.
  2. The school is required to procure more books subject to minimum of 1500 books in the school library and submit copy of purchase bill as evidence for same.
  3. The school is required to submit salary statement of the staff / teachers.
